

COMMUNIQUÉ FROM 2024 PSHAN ANNUAL CONFERENCE

Private Sector Health Alliance of Nigeria (PSHAN) recently hosted its annual conference, themed "Harnessing Private Sector Solutions for Universal Health Coverage in Nigeria's Evolving Health Insurance Landscape." This significant hybrid event took place over two days, with a physical gathering on Tuesday, June 25th, 2024, and a virtual session on Thursday, June 27th, 2024.

Dr. Tayo Aduloju, CEO of Nigerian Economic Summit Group (NESG), emphasized the pivotal role of private sector solutions in achieving Universal Health Coverage (UHC). He highlighted inefficiencies in government budgeting and resource wastage, the need to increase health revenue allocation and a strategic national financing framework. He underscored the need for technology integration, especially blockchain, to enhance the national referral system. Furthermore, Dr. Aduloju advocated for a corporate-led financing approach, strengthened private sector funds, and partnerships with commercial banks and Development Finance Institutions (DFIs). He advocated for a combined approach to health insurance, merging social and private packages, and recognizing the health sector as a critical economic driver. This integration, Dr. Aduloju stressed, would significantly enhance life expectancy and overall health outcomes.

Action Points

1. Equity and Community Engagement

- Implement cross-country learning and local solutions for equitable healthcare access.
- Engage communities and the private sector to democratize healthcare access.
- Enhance public education and awareness about health insurance through advocacy campaigns.



2. Innovation and Technology

- Promote innovative health insurance initiatives through domestic resource mobilization and private partnerships.
- Use technology to improve insurance uptake and awareness.
- Explore innovative financing models and leverage pharmacy stores for health insurance services.

3. Policy Advocacy and Regulatory Frameworks

- Advocate for policies that increase health insurance awareness and acceptance.
- Strengthen regulatory frameworks to enhance health insurance efficiency.
- o Address policy gaps to improve funding for health.

4. Private Sector and Financing

- Increase private sector participation in the health insurance ecosystem.
- Develop a corporate-led approach to financing, including partnerships with commercial banks and Development Finance Institutions (DFIs).
- Explore alternate tax sources such as telecommunication funding, seed funds, and diaspora fund taxes.

5. Research, Development, and Academic Partnerships

- Focus on research to improve health insurance designs and policies.
- Partner with academic institutions for data sharing and evidence-based health insurance policies.
- Implement monitoring and evaluation through research and data-driven policies.
